We guarantee that the Scottish Terrier purchased is from the above said Sire & Dam. It is eligible for registration with the American Kennel Club (AKC). MacTavish Scotties has made every effort to provide you with a healthy puppy. Please take your puppy to the Vet within 7 days of purchase. During the initial exam, should your veterinarian find your puppy to have a major health problem that would cause it to be a poor health risk that is clearly attributable to the Seller, you MUST contact us within 24 hours and a written explanation and documentation of any tests and their results from the Buyers Veterinarian must be provided. The puppy along with its registration papers must be returned within 72 hours of the initial exam. Upon its return, a full refund of purchase price will be given. All shipping costs and veterinarian bills are the responsibility of the Buyer, and are non-refundable. **Breeder** will not be responsible for any medical expenses incurred by the Buyer once buyer has taken possession of the puppy.

- **Buyer** agrees to insure the puppy's good health by taking good care of the puppy and providing appropriate **premium** food, housing, and medical care. As a responsible puppy owner/buyer you must provide your puppy with routine preventive care and all vaccinations and annual physical examinations by a licensed veterinarian, failure to do so will void this warranty. Your puppy has been on a vaccination & worming schedule and is up to date; these records will be provided to you. Please take these records to your veterinarian, as it is very important to continue with these vaccinations after you get your puppy home.
- **Buyer** agrees that MacTavish Scotties may continue to use the puppy's name, image and other information in advertising MacTavish Scotties.

Buyer guarantees to offer first right of refusal to **Breeder** if the Buyer decides to no longer keeps the dog. We want the dog back if you are unable to keep and care for the dog. This is a lifetime guarantee!

Pet Puppies are sold on limited registration only. It is agreed to and required that every pet puppy be spayed or neutered before 8 months of age.
